- Residential address(es) for the tax year
- Mortgage interest
- Real Estate closing disclosures and sales information
- Second mortgage interest paid
- Property taxes paid
- Energy credits
- Private mortgage interest documentation

#### FINANCIAL ASSETS

- Interest income statements
- Dividend income statements
- Proceeds from broker transaction

#### FINANCIAL LIABILITIES

• Auto loans and leases (car value) if the vehicle is being used for business

- Student loan interest paid
- Early withdrawal penalties on CD's and other deposits

#### **EXPENSES**

- Gifts to charity (qualified written statement from charity for any single donations of \$250 or more)
- Unreimbursed expenses related to your volunteer work
- Job related education expenses
- Childcare expenses
- Medical savings account- Balance of HSA at year end.
- Adoption expenses
- Alimony paid
- Tax return preparation fees and expenses

# SELF-EMPLOYMENT DATA

- Access to accounting system or spreadsheet
- K-1's from Partnerships or S Corporations
- Business-related expenses: Receipts and other pertinent documents
- Farm-related expenses: Receipts and other pertinent documents
- Employment taxes and other business taxes paid for the current year
- Vehicle- Make, model, percentage of business use and mileage for year
- Home in office deduction for self-employed: Square footage of office/total home

# **MISCELLANEOUS TAX DOCUMENTS**

- Federal, state and local estimated income tax paid for the current year
- IRA or other tax retirement plan contributions: If self-employed, identify as "for self" or "for employees"
- Records of medical expenses
- Records for any other expenditures that may be deductible
- Records for any other revenue or sale of property that you may need to report
- Prior 2 years tax returns
